FOREWORD

The International Trade Administration Commission of South Africa (ITAC) is delighted to publish its first edition of the Trade Indicators 2014. It gives a reflective summary of the most commonly used indicators in the field of international trade, and aims to promote evidence-based policy making. The indicators are designed to benchmark trade policy and performance, and are based on data retrieved from South African and external sources, presented in a standardised format for quick reference.

The following themes are covered: trade dependence and performance, specialisation and competitiveness position, trade policy and administration, trade facilitation as well as industrialisation and sustainable development. In addition, the indicators are complemented by trade-at-a-glance (TAAG) tables for 2013, as an annexure.

The trend analysis that is included for each indicator is in recognition that the degree of prosperity realised from trade depends on what a country trade on, how much it can trade and who it can trade with. The results confirm that South Africa has made significant progress in opening up its market relative to its emerging counterparts and further point to the need for necessary structural changes required to significantly alter the export basket beyond the range of products that reflect South Africa's static comparative advantage.

As a result of trade reform, South Africa's combined external trade as a share of GDP has expanded rapidly over the last twenty years. The GDP share of total trade (export plus imports) increased from its lowest level of about 36 per cent in 1994 to 62 per cent in 2013. The recent negative merchandise trade balances with its major trading partners including the EU, China, India and Japan, and strong growing trade surpluses recorded with Africa are indicative of South Africa's growing importance in the continent.

Despite increased efforts to improve intra-regional trade flows, trade between South Africa and the rest of Africa still remains considerably low. Taking advantage of the rapidly growing African markets, levelling the playing field and making strides towards improving competitiveness, are essential for addressing the growing problems of unemployment, poverty and inequality.


1. OPENNESS

The share of the sum of total exports and imports of merchandise goods and services

Definition in gross domestic product (GDP). This indicator ranges from 0 to 100. The higher the value the more open the economy is in the global economy.

South African trade has expanded enormously, with total trade accounting for more than half of the country's GDP since 2001. The country's openness indicator reached a peak of 75% in 2008 and appears to be the most open economy within the group according to the measure (except for Germany and UK). The average ratio of total trade to GDP in South Africa over the past 12 years is about two times as large as that observed in Brazil, Japan and US.



2. SHARE IN WORLD MARKET

Definiti	on	The ratio of the South Africa's total exports to total world exports.
Analysi		Despite its increased exposure to the rest of the world, the share of South Africa's exports in the global market remained muted and below its emerging market partners since 2001. This implies that South Africa's trade openness is import-driven. In 2013, the share of South Africa's exports to total world exports was 0.51%, down from 0.54% in 2012. The BRICs importance in the global export market continues to
		grow, with China accounting for approximately 12% followed by Russia (2.8%), India (1.7%) and Brazil (1.3%) in 2013.






3. PER CAPITA EXPORT

Definition	The ratio of total exports to population.
	The country's per capita export ratio has increased three-fold over twelve years. Manufacturing remains the sector with the highest per capita exports followed
Analysis	by mining and agriculture. However in 2013, agriculture experienced significant per capita exports, recording an increase of 31% while other sectors increased by approximately 12%.



4. EXPORT-OUTPUT RATIO (EOR)

Definition	The ratio of total exports to total output
Analysis	At 14.9% in 2013, the share of output exported by all industries remains below the 2009 pre-crisis levels of 17%. South Africa is well endowed with mineral resources and the mining sector has the highest share of output exported followed by manufacturing, agriculture and services. Notwithstanding a marginal gain recorded in 2013, the mining sector's export-output ratio of 59%, still remains below pre-crisis levels of 66%. In contrast, the share of output exported by the agricultural sector
	doubled from its 2007 pre-crisis level of 15% to 30% in 2013.



5. IMPORT-DOMESTIC DEMAND RATIO (IDR)

Definition	The percentage of domestic demand satisfied by imports. This indicator is often referred to as import penetration.
	Total import penetration in the economy reached a peak of 18% in 2008 before
	declining to 13% during the recession of 2009. In particular, the mining and

declining to 13% during the recession of 2009. In particular, the mining and manufacturing sectors recorded a significant decline in import penetration during 2008-2009 while import penetration in the agriculture and services sector remained muted. Despite a marginal increase recorded in 2013, import penetration in all sectors (except for manufacturing) remained below pre-crisis levels.






6. TRADE BALANCE

Definition	The difference between the total value of exports and imports
	While South Africa remains more open than its emerging market peers (i.e. BRICs), its
	merchandise trade balance remained in deficit from 2001 to 2013, widening from R0.2
	billion in 2001 to R183.1 billion in 2013. On a sectoral level, the manufacturing recorded the
	highest trade deficit, widening from R178 billion in 2012 to R244 billion in 2013 while the
Analysis	deficit in the services sector increased from R20 billion to R26 billion in the same period.
	Conversely, in spite of labour strikes in 2013, the mining sector recorded a trade surplus in
	the same period. South Africa recorded negative merchandise trade balances with many
	of its trading partners, namely EU, China, Brazil and India. Positive balances were recorded
	only with Africa, Japan and the US.

7. MAJOR EXPORT AND IMPORT CATEGORIES

Goal and definition

The overriding goal of the South Africa' Industrial Policy Action Plan (IPAP) is to advance industrial development upgrading and support the growth and diversification of manufacturing sector from traditional to non-traditional tradable goods. The indicator identifies product categories with high export and import shares in the domestic economy.

Analysis

South Africa's export profile remains resource based, with mineral products and precious stones accounting for almost 50% of total exports between 2010 and 2013. The top five export product groups grew at double digits except precious stones which recorded a negative average annual growth rate of 0.2% in the same period. The Import profile is dominated by a mixture of capital equipment and consumer goods. The top five import products recorded significant declines during the period 2010-2013.

8. EXPORT DIVERSIFICATION AND CONCENTRATION RATIO

Definition


Export diversification index measures the absolute deviation of a country's exports from the standard world structure. It measures the change in composition of a country's export basket. The index values range from 0 to 1, values closer to 0 indicate a higher degree of diversification and values close to 1 indicate increasing concentration of a country's export basket.

Export concentration index (also known as Herfindahl-Hirschmann index) measures the degree of market concentration. The index varies from 0 to 1. Higher values of the index indicate increasing concentration with a value of 1 indicating extreme concentration. Values close to 0 indicate a more diverse combination of exports.

Analysis

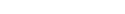
The degree of export diversification in South Africa decreased between 2001 and 2012. Subsequently, despite a decline in 2009-2010, export concentration increased during 2001-2012. South Africa's export basket is concentrated in primary commodities, resource-intensive and low-technology-intensive goods. Compared to the rest of Africa, South Africa's export basket was relatively more diversified during the period 2001-2012. However, South Africa's export diversification still lags behind its emerging market peers (i.e. China, Brazil and India) and major trading partners EU, US and Japan. This suggests that trade between South Africa and the rest of the continent has the potential of becoming a key source of export diversification.

9. TRADE INTENSITY COEFFICIENT

Definition

Export (import) intensity is defined as the share of country i's exports going to trading partner j relative to the share of world exports going to that partner. Similarly for import intensity. Export (import) intensity measures whether country i exports (imports) more, as a percentage, to (from) country j than the world does on average and takes a value between 0 and $+\infty$. Values greater (less) than 1 indicate an 'intense' bilateral trade relationship and implies bilateral trade flow that is larger (smaller) than expected, given the partner country's importance in world trade.

Analysis

South Africa's export and import intensity with its major trading partner, the EU, has declined over the period 2001-2012 while trade with China has intensified in the same period. In particular, South Africa's trade became more intensive than expected with China post-2008, making China South Africa's second largest single trading partner in 2012. South Africa exports and imports more to the rest of Africa than the rest of the world as suggested by high trade intensities in 2012, reflecting Africa's growing importance in South Africa's trade. Within the BRICs, import and most importantly export intensity has declined quite substantially between South Africa and Brazil, while import intensity with India doubled between 2001 and 2012. Trade intensity with Russia remains very low.

SPECIALIZATION AND COMPETITIVENESS POSITION

10. REVEALED COMPARATIVE ADVANTAGE (RCA)

Definition

The index measures a specific product's share in the country's total exports relative to a share of the product in world total exports. A country has a revealed comparative advantage (RCA) in production of product j when RCA>1. When RCA<1, a country has a revealed comparative disadvantage in production of product j

Analysis

South Africa's RCA lies in resource-intensive and non-fuel primary commodities. Of the top 5 products that have a comparative advantage, the mining industry has the largest comparative advantage particularly in mineral products such as ore. Some sectors such as furniture and metal fabrication experienced significant declines in RCA of 65% and 42% during 2006-2012 respectively. Improvements in RCA were recorded in the production of textiles such as wool and agricultural products such as fruit produce. South Africa is by far losing its comparative advantage in the clothing and footwear industry, particularly in products such as knitted fabric and apparel.

11a. EXPORT SPECIALIZATION RATIO (ESR)

Definition

The index measures a specific product's share in the country's total exports relative to a share of the product in a particular export market. A country has export specialization in production of product j in market k when ESR>1. When ESR<1, a country does not have export specialization in production of product j in market k

Analysis

South Africa's export specialization with its major trading partners is concentrated in resource-intensive (Pearls, precious stones, metals, coins, etc., raw hides and leather, and wool)) and low-technology-intensive manufactures (Railway, tramway locomotives, rolling stock, equipment). Between 2006 and 2012, South Africa's export specialization in resource-intensive manufactures such as pearls, precious stones, metals, coins etc. declined considerably in China, EU and US. Specialization in non-fuel primary commodities such as ore, increased significantly in the EU and US markets between 2006 and 2012, which does not bode well for export diversification.



Analysis

South Africa does not have export specialization in high skill- and technology-intensive manufactures, and resource-intensive manufactures in export markets with its major trading partners. This is particularly evidenced in sectors such as pharmaceuticals, clothing and textiles, and metal fabrication (particularly tin and articles of tin).

12. INTRA-INDUSTRY TRADE INTENSITY

	The Grubel-Lloyd Index is used to calculate the intensity of inter-industry trade (IIT). It
	measures the balanced two-way trade in goods produced by the same industry. The
Definition	IIT index varies between 0 (pure inter-industry trade) and 1 (pure intra-industry
	trade). Higher values indicate a higher level of IIT between countries and shows that
	a country is more integrated in the global economy.

The level of intra-industry trade (IIT) in the top 5 products with the highest revealed comparative advantage (RCA) increased between 2001 and 2006. Despite this, intraindustry trades remains low and is skewed towards inter-industry trade, particularly in mining (ores, slag and ash), textiles (wool and yarn) and agricultural products (edible fruits, nuts and melons). As of 2012, sectors such as furniture manufacturing and metal fabrication enjoy a mixture of inter-industry trade and intra-industry trade. Despite a relatively low RCA, the clothing sector has high inter-industry trade, while IIT in sectors within the metal fabrication (tin and articles thereof) has contracted significantly between 2001 and 2012.

13. COMPLEMENTARITY INDEX

Definition

The Index measures the compatibility of trade profiles between two countries. The index value ranges between 0 and 1. The higher the index value, the more compatible trade profiles are between the countries. Countries that have bilateral trade agreements and trade with each other, are likely to exhibit high trade compatibility (or trade complementarity).

Analysis

In 2012, the European Union (EU) and the United States (US) were the most compatible trading partners with South Africa compared to the BRICs and Japan. In particular, the complementary index between South Africa and the BRICs has been below 0.5 and declining between 2009 and 2012. This suggests that trade profiles between South Africa and the BRICs are becoming less compatible.

14. TRADE CORRELATION INDEX (TCI)

Definition

A measure of similarity of the trade specialization index between countries. Index varies from -1 to1. Positive values indicate that the economies are competitors in the global market and negative values indicate that the economies do not specialize in the production of the same goods, and hence are natural trading partners.

Analysis

The EU is South Africa's major trading partner and the two economies specialize in different products and thus can be considered natural trading partners. This is also evidenced in the high level of compatibility in their export and import profiles. Prior to 2005, China and South Africa competed in the global export markets, however, over time China has become one of South Africa's major trading partners. Trade correlation between South Africa and China declined from 0 to -0.27 from 2001 to 2012. Similarly, India and South Africa's similarity in trade specialization index declined from 0.01 to -0.09 between 2009 and 2012. Brazil and the US continue to be South Africa's competitors in the global market post-2009.

15. EXCHANGE RATE


Definition

The real effective exchange rate measures how the weighted-average purchasing power of the Rand currency has changed over time. An increase in the real effective exchange rate (i.e. real depreciation), increases the price of imported goods while making the price of exportable goods more competitive relative to non-traded goods in the international market.

Analysis

In nominal terms, the rand experienced significant depreciation against its major trading partner currencies in 2013, falling by 16.1 against the British pound, 17.5% against the US dollar and 21.5% against the euro. However, the real effective exchange rate depreciated by only 9.4% in 2013. Despite nominal and real depreciation of the rand since 2011, export performance remained muted, reflecting structural constraints to export growth. While a weaker rand is expected to boost exports, a larger content of imported intermediate inputs into manufactured final goods may weaken export growth.

16. TERMS OF TRADE INDEX (TOT)


Definition

Terms of trade: The ratio of the export unit value index to the import unit value index. It is calculated by dividing the export price index by the import price index.

Purchasing power of exports: the value index of exports deflated by the import unit value index.

Analysis

Following an upward trend during 2001-2011, South Africa's terms of trade deteriorated in 2012, declining by 6.6% while the purchasing power of exports declined by 11%, contributing to a protracted trade deficit. South Africa's terms of trade grew faster than its emerging market peers, Brazil and India and major trading partners, EU and the US. The terms of trade for Asian economies, China and Japan, experienced significant and persistent declines. Despite having increased its terms of trade faster than its trading partners, South Africa's purchasing power of exports lags behind that of China, Brazil and India.

17. COMPETITIVENESS EFFECT (CE)

Definition

The competitiveness effect measures the percentage change in competitiveness of a country's exports in the global market for a selected sector in a given year. It is defined as a change in the exporting country's share in destination markets' imports times the initial share of partner countries' import in world trade. The indicator value varies between - ∞ and + ∞ , with positive values indicating a gain in market share due to increased competitiveness in the global market.

Analysis

Being one of the sectors with the lowest comparative advantage, the clothing and textiles experienced the largest loss in export share in the global market during the economic recession of 2009. In contrast, the mining and consumer electronic sectors were relatively unscathed during the economic crisis, recording a gain of 5.9% and 1.7% respectively in market share in the global economy due to increased competitiveness. In 2012, the mining and consumer electronics sectors continued to record gains in market share while lacklustre competiveness in the manufacturing, non-electronic machinery, textiles and transport equipment resulted in market share losses. Following declines in competitiveness post 2009, the clothing and chemical sector recorded an improvement in 2012.

18. TARIFF PROFILES


Definition

The weighted mean most favored nations (MFN) tariff is the average of MFN rates weighted by the product import shares corresponding to each partner country. The simple mean bound rate is the unweighted average of all the lines in the tariff schedule in which bound rates have been set.

Analysis

South Africa continued to liberalize its trade between 2004 and 2012. The average MFN tariff rate for all products in South Africa was 5.7% in 2012 compared to 5.6% in 2004. Average MFN tariffs on primary products declined marginally in South Africa over the same period while significant declines were experienced in China, Japan and EU. However, average MFN tariff rates on manufactured products increased marginally in South Africa and its trading partners except the US. The average MFN tariff rates in South Africa remain below the bound rates and hence provide policy space to support the domestic manufacturing industry.

19. TRADE REMEDIES


Definition

Trade remedies are trade policy tools that allow governments to take remedial action, in the form of anti-dumping duties, countervailing duties or safeguard duties or quotas, against imports which are causing injury to a domestic industry.

Analysis

The number of trade remedy measures imposed by South Africa is relatively small compared to its major trading partners and emerging economy counterparts. In 2013, South Africa imposed only 2 anti-dumping duties, down from 5 in 2001 and 15 in 2002 (the number of measures imposed in 2002 was directly linked to sunset reviews of existing measures). The number of anti-dumping measures imposed by the EU, the US as well as India and China has also declined over the period 2008-2010 compared to 2011-2013. However, the number of anti-dumping measures imposed by Brazil (57) and India (68) remained high relative to South Africa (3) during the period 2011-2013. With the exception of the EU and US; South Africa's emerging economy counterparts (i.e. BRICs), make little use of countervailing duties.

20. COST TO EXPORT AND IMPORT PER CONTAINER


Definition

The cost to import per container is based on the fees levied on a 20-foot container in U.S. dollars and includes all the fees associated with completing the procedures to export or import the goods. These include costs for documents, administrative fees for customs clearance and technical control, customs broker fees, terminal handling charges and inland transport. The cost measure does not include tariffs or trade taxes.

Analysis

The cost to export and import per container in South Africa was below the world average until it surged post-2008. In 2013 alone, the cost to import was 9% above the world average of US\$1823 per container. On the other hand, the cost to export was 13% above the world average of US\$1515. Compared to its major trading partners, it costs relatively more per container to either export or import in South Africa. South Africa's cost to export is almost three times that of China and hence partly explains South Africa's meagre export competitiveness.




21. INVESTMENT

To increase the level of productive investment across the sectors of the economy, in Goal particular the manufacturing sector with a view to achieve the IPAP, NGP and NDP objectives.

The manufacturing sector recorded the largest decline in investment during the 2008-2009 economic recession, declining 22% while investment in agriculture and services contracted by 15.2% and 5.6% respectively. In contrast the mining sector increased investment levels by 6% in the same period. Following the economic recovery in 2010, manufacturing sector investment increased at a faster pace than all sectors, recording a 9.3% increase during 2010-2013 while other sectors grew just below 5%.

22. REAL VALUE-ADDED


Goal

To increase the level of real value added across the sectors of the economy, in particular the manufacturing sector with a view to achieve the IPAP, NGP and NDP objectives.

Analysis

The manufacturing sector experienced the sharpest decline in real value-added followed by the mining sector during the 2008-2009 economic recession. During 2010-2013, the services sector recorded the highest gains in real value-added followed by the manufacturing and mining sectors. Continued labour strikes coupled with declining employment levels in the mining sector, saw real value-added contracting by 0.1% during 2010-2013.

23. EMPLOYMENT


Target

To increase the level in employment across the sectors of the economy, in particular the manufacturing sector with a view to achieve the IPAP, NGP and NDP objectives.

Analysis

Following significant contractions in employment levels across different sectors in the economy during the 2008-2009 economic recession, the manufacturing sector continued to shed jobs during 2010-2011 in line with contractions in investment levels. Employment in the manufacturing sector only improved marginally during 2012-2013 despite investment growth of 9.7%, and employment still remains below pre-crisis levels. Similarly, employment in the agricultural sector, though it has improved, it still remains pre-crisis levels. On the contrary, employment in mining improved gradually after 2009, however, recent labour disruptions saw employment in the mining sector contracting by 2.7% in 2013.
