TERMINATION OF THE ANTI-DUMPING DUTY ON WIRE ROPES AND CABLES ORIGINATING IN OR IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA AND THE REPUBLIC OF KOREA, ANTI-DUMPING DUTY ON WIRE ROPES AND CABLES OF A DIAMETER LESS THAN OR EQUAL TO 32MM ORIGINATING IN OR IMPORTED FROM GERMANY AND THE UNITED KINGDOM, ANTI-DUMPING DUTY ON STRANDED WIRE ORIGINATING IN OR IMPORTED FROM GERMANY, THE UNITED KINGDOM AND THE REPUBLIC OF KOREA, ANTI-DUMPING DUTY ON STRANDED WIRE OF A DIAMETER LESS THAN 12.7MM ORIGINATING IN OR IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA AND THE COUNTERVAILING DUTY ON WIRE ROPES AND CABLES AND STRANDED WIRE ORIGINATING IN OR IMPORTED FROM INDIA

- 1. In accordance with the provisions in Section 53.1 of the Anti-Dumping Regulations, any definitive anti-dumping duty shall be terminated on a date not later than five years from its imposition, unless the authorities determine, in a review initiated before that date on their own initiative or upon a duly substantiated request made by or on behalf of the domestic industry within a reasonable period of time prior to that date, that the expiry of the anti-dumping duties would likely lead to continuation and/or recurrence of dumping and material injury.
- On 28 June 2013, the International Trade Administration Commission of South Africa (the Commission) notified the interested parties through Notice No. 664 of 2013 in Government Gazette No. 36592, that unless a

substantiated request is made indicating that the expiry of the antidumping duties on imports of wire ropes and cables and stranded wire originating in or imported from Germany, the United Kingdom, the People's Republic of China and the Republic of Korea and countervailing duties on wire ropes and cables and stranded wire originating in or imported from India would likely lead to the continuation and/or recurrence of dumping and material injury, the anti-dumping duties and countervailing duties will expire on 12 February 2014.

- 3. The application was received from Scaw South Africa on 30 September 2013, representing 100 percent of the SACU industry by production volume. After all the deficiencies were addressed an updated application was received on 01 November 2013, indicating that the expiry of the anti-dumping duties on the wire ropes and cables of a diameter exceeding 32mm originating in or imported from the UK and Germany and stranded wire of a diameter exceeding or equal to 12.7mm originating in or imported from the PRC would likely lead to the continuation and/or recurrence of dumping and material injury to the SACU industry.
- 4. The applicable anti-dumping duties and countervailing duties are as follows:

5. The applicant indicated that it is not applying for a review of the antidumping duties on wire ropes and cables of a diameter less than or equal to 32mm from the UK and Germany and on wire ropes and cables originating in or imported from the PRC and Republic of Korea. Neither is it applying for a review of the countervailing duties on wire ropes and cables from India.

6. The applicant also indicated that it is not applying for a review of the antidumping duties on stranded wire of a diameter less than 12.7mm originating in or imported from the PRC and stranded wire originating in or imported from Republic of Korea, the UK and Germany. Neither is it applying for a review of the countervailing duties on stranded wire from India.

RECOMMENDATION

The Commission therefore, decided to recommend to the Minister of Trade and Industry that the following anti-dumping and countervailing duties be terminated on the five year expiry date, that is 12 February 2014:

- the anti-dumping duties on wire ropes and cables of a diameter less than or equal to 32mm originating in or imported from the UK and Germany;
- the anti-dumping duties on wire ropes and cables originating in or imported from the PRC and Republic of Korea;
- the anti-dumping duties on stranded wire of a diameter of less than 12.7mm originating in or imported from the PRC;
- the anti-dumping duties on stranded wire originating in or imported from the UK, Germany and Republic of Korea; and
- the countervailing duties on wire ropes and cables and stranded wire originating in or imported from India.
