CREATION OF A REBATE ITEM FOR WELDED STEEL TUBING OF CIRCULAR CROSS-SECTION FOR THE MANUFACTURE OF REFRIGERATORS AND FREEZERS

Synopsis

Whirlpool South Africa (Pty) Ltd applied for the creation of a rebate provision for welded steel tubing of circular cross-section for the manufacture of refrigerators and freezers. No objections were received to the application. The Commission recommended the creation of the rebate item as it would improve the applicant's competitive position and as the steel tubing in question is not manufactured domestically.

The application

1. Whirlpool South Africa (Pty) Ltd applied for the creation of a rebate provision for welded steel tubing of circular cross-section steel for the manufacture of refrigerators and freezers.

- 4. Due to advancement in the field, seamless tubing is no longer manufactured for this purpose and according to the applicant it had to switch over to welded steel tubing.
- 5. No objections were received following the publication of the application in the Government Gazette.

Recommendation

6. The Commission recommended the creation of an additional rebate item as follows: "Tubes, pipes and hollow profiles, welded, of circular cross-section of iron or non-alloy steel of tariff subheading 7306.30 for the manufacture of refrigerators and freezers of heading 84.18".
